Intended Audience

The Annual Assembly of the American Academy of Hospice and Palliative Medicine (AAHPM) and the Hospice and Palliative Nurses Association (HPNA) is designed for physicians, nurses, and other healthcare providers interested in acquiring, maintaining, or expanding the skills needed to care for patients with terminal illnesses.

Purpose

This session will include presentations and interactive sessions on budgeting, billing and reimbursement, pharmacy management, and optimizing your performance. Practical Approaches to Palliative Wound Care (P2)

Pressure ulcers, malignancies, and other chronic wounds have relatively high prevalence in patients with advanced life-threatening illnesses. Both the wound and the sense of being wounded can cause considerable suffering for patients, families, caregivers, and members of the healthcare team. During this interactive, hands-on workshop, the presenters will discuss recent prevalence data from their hospice, guide participants through the underlying pathophysiology of chronic healable and non-healable wounds, and use clinical cases to discuss effective approaches to wound assessment and management based on the state-of-the-art wound care literature. Discussion will also include the underlying pathophysiology of each of these symptoms and case-based approaches to their assessment and management, including the use of both systemic and topical antibiotics, analgesics, and anesthetics.

Communication Skills for Transitions in Goals of Care (P3)

Talking to a patient and his or her family about shifting goals of care from disease-modifying therapy to a focus on comfort requires a foundational set of communication skills. This session will review a teaching model for complex communication skills based on empirical studies, including behavioral outcome studies, and will show that this method is associated with the acquisition of new skills. Although these skills are critical for clinical excellence in palliative care, the teaching skills required have not been disseminated. This preconference workshop will introduce Oncotalk, an approach that teaches a cognitive roadmap to the conversation, which will be followed by intensive mentored skills practice.

This skill-building workshop is intended for palliative care clinicians serving on ethics committees, with a focus on clinical ethics consultations. A corollary benefit will be enhanced skills at addressing ethical dilemmas in one's clinical work as a palliative care professional. A didactic overview will cover fundamental bioethics principles and concepts. An interactive format, including a simulated ethics consultation team, will demonstrate core competencies for ethics consultations and develop skills in ethical case analysis using a standard systematic approach. Time will be allotted for an interdisciplinary panel to address workshop participants' specific questions.

Grief and Its Mulifaceted Nature: A Clinical- and Skill-Oriented Workshop (P5)

This interactive, interdisciplinary, skill-oriented, and case-based workshop will review the most current evidence-based research on assessment, diagnosis, and treatment of grief in the context of a serious or life-limiting illness. Grief is a central experience in the lives of patients and family members who are receiving hospice and palliative care; therefore, it is essential to understand the factors that can facilitate or complicate the grieving process. The literature shows that complicated grievers are at higher risk for suicidal behavior, psychopathology, and physical illness, making this topic relevant to the field of palliative care. In addition, hospice and palliative care patients may often experience symptoms of grief and/or depression, which providers need to expediently recognize, assess, and adequately treat. The session will include presentation and discussion of clinical cases, group activities, and role-play by the presenters, a clinical psychologist and a physician.

Creating Pediatric Hospice and Palliative Care Programs and Fellowships (P10)

This program is a collaborative effort of pediatric palliative care leaders designed to make pediatric palliative care more broadly available to the patients and families who can benefit from it. Specifically, strategies to develop programs within general community hospices as well as specialty pediatric palliative care will be presented, ranging from inpatient to home-based to comprehensive programs for children with palliative care needs. In addition, a panel of pediatric palliative medicine fellowship directors will discuss what is needed to develop pediatric fellowship training experiences for adult palliative medicine fellows and for pediatric subspecialists in palliative medicine.

Hospice in Long-Term Care: Regulations, Ethics, Quality, and Collaboration (P6)

Forty percent of deaths in the United States occur in long-term care facilities (LTCFs). Despite evidence that hospice care improves outcomes for dying patients and their families, only 5% of dying LTCF patients receive hospice services. Optimal collaboration between hospice and LTCFs requires an understanding of the others' perspectives, needs, strengths, and limitations. Both providers must understand how to coordinate care plans. They must also recognize and resolve ethical and legal issues related to collaboration. Because growth of hospice services to LTCF patients has resulted in aggressive state and federal oversight of care delivery and a review of current and future spending on these services, all parties need to understand and respond to the potential liabilities of oversight and proposed changes in reimbursement.

Leadership has been defined as "the ability to inspire others to strive and enable them to accomplish great things." Good leadership is all about working collaboratively and knowing "when to step up and when to let others step up." Contrary to popular opinion, leadership is a state, not a trait, and is basically a set of skills that can be learned. This interactive, skill-oriented preconference session for women in the palliative care workforce will use a variety of learning techniques (minididactics, group brain storm, mini case studies, small-group role play, self-reflection, and self-assessment exercises) to explore the art and practice of leadership. Learners will have ample opportunity to interact with the content, their fellow learners, and the presenters and will hopefully leave the session with a set of tools and a practical roadmap to nurture the leader within.

Advanced Pediatric Pain Management (P8)

More than 15,000 children age 0 to 17 years die from life-limiting conditions each year in the United States. Data reveal the majority of those children suffer from pain during their last weeks of life. The management of intractable pain in children remains a challenge. This session will summarize the therapeutics of intractable pain; the management of breakthrough pain; the assessment of nonnociceptive sources of pain in the setting of refractory distress; psychotherapeutic interventions; integrative treatment modalities; practical considerations of adjuvant analgesia; and advanced pain management, including the administration of subanesthetic ketamine, low-dose propofol, and methadone. The second part of the workshop will use a small-group approach with case examples to apply advanced strategies in the management of intractable pain in the pediatric palliative care and hospice settings.

It is generally recognized that the original concept of advance directives is flawed. In response to the difficulties with implementing advance directives, a new model, the Physician Orders for Life-Sustaining Treatment (POLST) Paradigm, has been developed to effectively identify and respect patients' wishes for treatment at the end of life. This new model includes five key components: (1) advance care planning; (2) documentation on standardized forms; (3) timing staged to reflect a patient's health status; (4) systems and processes designed to facilitate use, including triggers of initiating the discussion about treatment wishes; and (5) quality improvement through ongoing data collection and evaluation. This session will describe the national initiative to institute the use of a POLST Paradigm document in all 50 states (www.POLST.org), present findings from a 50-state study of barriers to POLST Paradigm implementation in state laws, discuss recent research documenting the efficacy of the POLST Paradigm form in nursing home and hospice settings, and engage participants in a dialogue regarding how to implement a POLST Paradigm system in their state or region.

As hospice and palliative medicine (HPM) fellowship programs move toward ACGME accreditation and a competency-based model, many implementation challenges continue. Faculty are expected to develop and implement a well-defined evaluation plan for competency assessment in all ACGME domains within a 12-month fellowship. The HPM Competencies Project Workgroup has recently completed its toolkit of proposed assessment methods. This workshop is designed for directors of active HPM fellowship programs and will introduce participants to the toolkit. Participants will have the opportunity to share current challenges and will be instructed on techniques for providing competency-based feedback to fellows with an opportunity to practice and receive feedback on these skills in small groups.

As life-sustaining therapies have emerged, so have clinical, ethical, and legal concerns about the appropriate use of these treatments at the end of life. The therapies of artificial hydration and nutrition, mechanical ventilation, renal dialysis, cardiac devices, and life-supporting medications, as well as blood products, will all be discussed. Each topic will be presented as case vignettes to highlight the current evidence of benefits and burdens of the therapy, the ethical and legal considerations, and the clinical management of symptoms at the time of withdrawal. Cultural and pediatric implications will be addressed, as will the moral distress of the clinicians who are part of the process.
